Cover is only operative for any Referees that play or participate at:

- Step 2 and below (Men's football)
- Tier 3 and below (Women's football)

If you have any teams that participate at Step 4 or above (Men's football) or Steps S1 or S2 (Women's football), please note that cover will not be in place, and you should apply online for stand alone coverage, please visit <a href="http://www.sportsguard.co.uk/liability">www.sportsguard.co.uk/liability</a>.

**Do you operate a licensed premises?** – this insurance includes coverage for licensed premises, however, if you are hiring or renting out premises to members of the club or members of the public for private functions, you will need to apply for additional coverage via our website <u>www.sportsguard.co.uk/events</u>.
